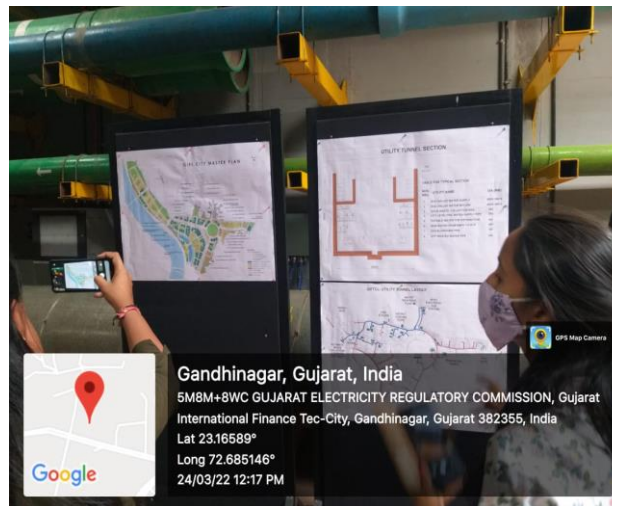
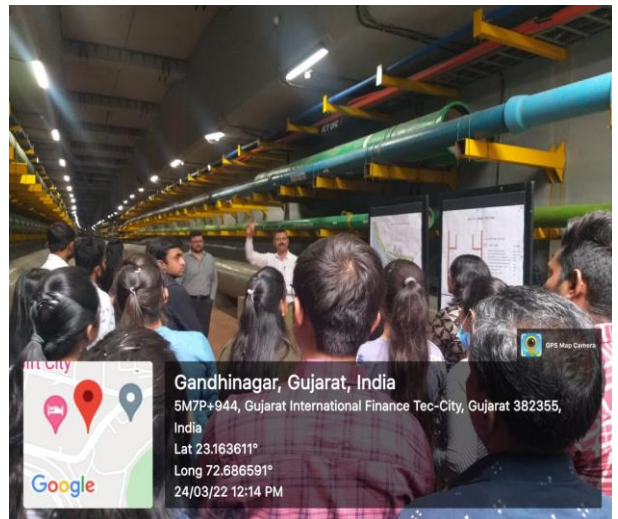

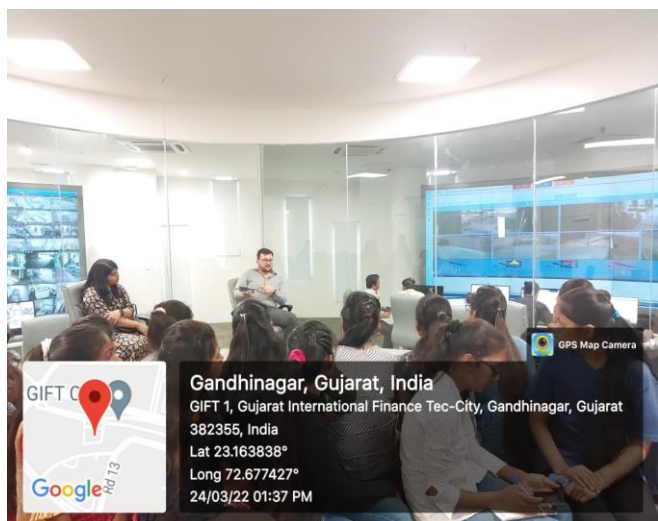
Conclusion:
